## Fee Waiver / Sponsorship Policy



### Fee Waivers / Sponsorship - Tab 8

- Board members interest to standardized county services fee waivers and sponsorships, 3-year summary of Board Approved Fee Waivers and Sponsorships
- Fee Waive Policy that was approved by the Board in 2009
- Sonoma Water Sponsorship policy approved in 2014
- Community Investment Fund Community Sponsorship Policy updated in August 2019.

### Fee Waivers / Sponsorship Three Options Proposed

**Option 1**. Maintain the status quo.

**Option 2**. Determine maximum amount of Contingency funds available for fee waivers and sponsorships that would be split equally between all districts

**Option 3**. Revise/Update Fee Waiver Policy and include Sponsorships that also governs department sponsorships.

### Fee Hearing / Sponsorship Option 3 – Staff Direction

**Option 3**. Revise/Update Fee Waiver Policy and include Sponsorships that also governs department sponsorships.

If Board selects this option, staff will need Board direction on the following questions:

- A. Should the policy establish a maximum sponsorship amount that a department can approve (e.g., \$2,500)? If yes, should limits apply to Sonoma Water and the Sonoma County Agricultural and Open Space District?
- B. Should the policy prohibit multi-year fee waivers after some period of time?
- C. Should new policy provisions apply to the Community Investment funds?

### Fee Waivers / Sponsorship Admin Policy - New Prohibition

Delegate Authority to the County Administrator & Auditor-Controller-Treasurer-Tax-Collector to develop an Administrative Policy

 Prohibits use of public funds for membership organizations that formally endorse candidates and/or ballot issues
