#### CAO Recommendations – Use of Available Sources

Maintain at least \$3.5 Million in Contingencies

 Utilize \$8.5 million in PG&E Settlement \$ to restore reserves spent due to 2017 Wildfires

 If 1x funding source is used for ongoing costs, program the equivalent of 3 years of funding

#### CAO Recommendations – Expenditures

- \$20.0 million in one-time funds to County-wide COVID-19 Response
- \$3.97 million in one-time funds to create a 20% FEMA Audit Reserve
- \$8.5 million of PG&E Settlement to replenish reserves drawn down as result of 2017 Wildfires
- \$817,000 Replace with ongoing source the use of Contingencies during the Office of Equity establishment


## CAO Recommendations - Above the Line Departmental Reductions Restorations

Utilize \$5.9 million in ongoing funds for departmental restorations

Saves 36.4 FTE, including 32.65 filled

 Utilize \$2 million in <u>one-time</u> funds for Fire Service Project to ensure that existing contracts can be maintained and to backfill Clerk Recorder Assessor for 2020 election costs
