Summary

This staff report briefly summarizes items proposed for the CoC Board meeting's Consent Calendar. All items will be approved with one motion (following a second, as well as public comment on Consent Calendar Items) except for those items removed from the Consent Calendar for separate discussion and action.

Discussion

Items on the Consent Calendar include:

1. The meeting's **proposed agenda**. The agenda contains all items that will be discussed by the Continuum of Care Board at today's meeting. **The agenda is attached as Attachment A.**
2. The **minutes** from the last or previous meeting(s). The minutes reflect a general summary of the previous meeting's (or meetings') activities and are not intended to reflect verbatim comments. **The minutes are attached as Attachment B.**
3. A **summary of follow-ups** from the previous meeting(s). At the previous meeting, CoC Board members and others asked for the Lead Agency staff to follow up on the following questions or comments.
 - a. **Definition of equitable distribution of services:** Still pending. Landing on what equitable distribution of services (including what "services" are) means involves a broader discussion

between members of the Continuum of Care that include the County of Sonoma, cities, the Strategic Planning effort, service providers, and more.

- b. **Summary Calendar of Funding Guidance/Decisions** that either the CoC Board or the CoC's Funding and Evaluation Committee will see in the coming 9 months. This document, shown as **Attachment C**, provides staff's summary of those funding items that will come before the CoC board. It's an estimate right now based on what we know at the time of this meeting.
- c. **CoC Competition detailed overview that was shared with the Board of Supervisors.** To learn more about HUD Continuum of Care Contracts, review **Attachment D**.
- d. **An update on Built for Zero's meeting schedule.** It is vital that all members of BFZ participate in the required meetings. Lead Agency staff will send out Outlook calendar reminders of these sessions. As a reminder:
 - i. **COHORT CALLS.** These include all local BFZ team members, including the Guiding Coalition (Outer Group) and the Improvement Team (Inner Group). These meetings are:
 1. 9/14/22 – Noon (we note here that turnout was bad. It is critical that all team members attend or designate someone who can consistently attend in their stead).
 2. 10/12/22 – Noon
 3. 11/9/22 – Noon
 - ii. **ONE ON ONE COACHING.** These are set for December 2022 and January 2023, with more details to be added.
 - iii. **SMALL GROUP CALLS.** These are for the Improvement Team (Inner Group) and are set for:
 1. 9/27/22 – 11:00 a.m.
 2. 10/25/22 – 11:00 a.m.
 3. 11/29/22 – 11:00 a.m.

4. **Stability Vouchers Commitment Letter.** On August 16, 2022, USHUD announced their new **Stability Voucher (SV)** program (for more information, link [here](#)). Stability vouchers are “designed to encourage a community-wide commitment to the goal of ending homelessness.” SVs can assist homeless persons, persons fleeing domestic violence, veterans, and others. To successfully compete, our two public housing authorities (PHAs) (Santa Rosa Housing Authority [SRHA] and Sonoma County Housing Authority [SCHA]) need to partner with local health and housing agencies to “leverage mainstream housing and healthcare.” PHAs also are encouraged “to partner with CoCs to support efforts to address unsheltered homelessness, including committing available vouchers and public housing units to these efforts. HUD seeks to prioritize PHAs to receive SVs who are partnering with CoCs on this effort.” Both the SRHA and the SCHA are interested in securing SVs, if available. To that end, the attached letter (**Attachment E**) states

the CoC's intent to work with the PHAs in developing appropriate supportive services for the SVs if they are secured.

Board members may ask, "why apply for SVs even as we have challenges with our EHV's and with supportive services?" The main reason is that oftentimes when US HUD announces a new program, it can later screen out (from subsequent rounds) those agencies that never applied for the first round. Staff at the PHAs and Lead Agency believe that this may be the case with SVs – we may not be able to secure them in this initial round, but we are helping our case for future rounds should conditions change.

5. **CoC Board Advocacy Relating to Reducing Barriers for Affordable Housing.** Relatively new as a part of the recurring HUD Continuum of Care competition, the CoC is scored on how the CoC has advocated for or otherwise worked to encourage the production of more affordable and market rate housing in the CoC's region. To this end and for the future period of October 1, 2022 through September 30, 2023, there is an opportunity for for the Continuum of Care Board to send letters of support to those jurisdictions who are pursuing the State of California's most proactive housing position – that being achieving a "prohousing designation" (PHD) from the California Department of Housing and Community Development (HCD). We know that the County of Sonoma, along with the City of Santa Rosa, the City of Rohnert Park, and the City of Healdsburg intend to proceed with this designation. Thus, approval of the Consent Calendar's action items would have the CoC send those cities and the County the attached (**Attachments F-I**) letters of support as they pursue PHD. Staff notified the cities and the County of the pending CoC action in regard to the letters.

HUD Continuum of Care Contracts

Continuum of Care funding awards are made through a national competition in which up to twenty local homeless services projects, providing permanent supportive housing and rapid re-housing to 261 homeless persons, are submitted together.

The 2021 Continuum of Care Consolidated Application was submitted in September 2021. HUD announced renewal awards in March 2022. The total award for the Continuum of Care was \$4,162,516 for the 17 projects listed in Attachment 2. Of this, \$1,533,126 representing six awards, is designated directly to the Commission for the following projects:

- Two renewal awards for Continuum of Care Rental Assistance (formerly known as Shelter Plus Care projects). These two contracts enable the Sonoma County Housing Authority to support 55 formerly homeless, disabled persons in scattered site housing throughout Sonoma County, matching rental assistance with supportive services provided by partners including Face to Face, and Social Advocates for Youth. The total amount of the two awards is \$736,080.
- A renewal award and a new expansion award, both supporting the Homeless Management Information System (HMIS), a HUD-mandated web-based client database which reports quality statistical information regarding the extent and nature of homelessness to HUD officials and to the US Congress, and provides invaluable information for local systems planning. The total amount of the two awards is \$327,157.
- One Coordinated Entry Project award that address HUD's mandate that communities accessing Federal Continuum of Care and Emergency Solutions Grant dollars would create a single front door into their homeless services system, in the amount of \$349,991. Sonoma County's Coordinated Entry System is a streamlined system designed to efficiently match people experiencing homelessness to available housing, shelter, and services. It prioritizes those who are most in need of assistance and provides crucial information that helps communities strategically allocate resources and identify gaps in service. Sonoma County's Coordinated Entry system employs a Housing First model that prioritizes individuals and families facing the highest vulnerability and needs for permanent, supportive housing. More information on the Coordinated Entry System can be found at <http://sonomacounty.ca.gov/CDC/Coordinated-Entry-System/>.
- The annual Planning award of \$119,898 is calculated at 3% of the total \$4.1 million award to Sonoma County agencies, to partially defray the cost of staffing the Home Sonoma County effort.

HUD will contract directly with the other eleven projects, representing a total of \$2,629,290 in support of the community as follows:

- Two permanent supportive housing projects operated by Catholic Charities, totaling \$784,961, which support housing for 35 chronically homeless persons at the Palms Inn and in scattered site apartments;

- \$97,842 for Mill Street Supportive Housing, a permanent supportive housing project operated by West County Community Services, which supports housing for 8 chronically homeless persons;
- \$292,843 for a permanent supportive housing project operated by Committee on the Shelterless (COTS), which supports housing for 18 chronically homeless persons in scattered site apartments;
- Two permanent supportive housing projects operated by Buckelew Programs, totaling \$375,196, which support housing for 18 homeless persons with mental illness, at least 6 of them chronically homeless persons, in scattered site apartments;
- Two rental assistance programs operated by Social Advocates for youth, totaling \$305,329, which supports housing for 16 chronically homeless transition aged youth in scattered site apartments;
- Two permanent supportive housing projects operated by Community Support Network, totaling \$121,188 for Stony Point Commons, (which supports housing for 16 chronically homeless persons with mental illness in a single-room occupancy facility) and the recently opened Sanctuary Villas project (five of the facility's nine beds for chronically homeless transition aged youth with mental illness);
- One award to the YWCA of Sonoma County, a renewal of their rapid re-housing program serving victims of domestic violence for \$260,040 serving vulnerable victims of domestic violence; and
- An award for Reach for Home, in the amount of \$87,931, to provide 17 persons with rapid re-housing financial assistance and case management in the North County.
- A new permanent supportive housing project for St. Vincent de Paul for \$303,360 to provide wrap around services for the Commons, a new permanent supportive housing project.

- c) Round 2 [FINAL] (Department of Health Services Director, Human Services Director & Child Support Services Director) - October/November 2022


Once a candidate is selected, there will be a meet and greet with the CoC Board in November or December 2022.

Distinguishing Characteristics

Oversees the preparation, justification, and administration of the Division's budget, grants, homeless and housing finance sources, and contracts; interprets, monitors, and ensures

compliance with contract and grant terms and conditions and other legislative requirements.

Develops and instills program and process improvements and practices in the Division; conducts studies of systems and procedures; evaluates and submits recommendations concerning the effectiveness of program operations; attends management staff meetings to advise on the progress of projects, programs, and studies; proposes program modifications to meet changing needs and simplify procedures.

Selects, trains, evaluates, and supervises division staff, directly and through subordinate managers and supervisors; meets with employees and employee organizations to discuss and resolve grievances and problems; confers with professional staff to resolve complex issues.

Collaborates with other divisions within Health Services, County departments, cities, other government agencies, nonprofits, and service providers to align resources and develop a sustainable and responsive supportive system to improve client experiences.

Supports regional, state, and federal policies that reduce homelessness and improve the supportive housing system.

Reviews legislative proposals for content and appropriateness; provides recommendations on necessary changes and approaches to County advocacy positions; analyzes and interprets legislative or legal changes and regulations from federal, state, and local agencies which affect assigned programs; consults with legal counsel as needed.

May represent the department and the County before individuals, private groups, the Board of Supervisors, the Continuum of Care, and other public groups or agencies; conducts and participates in public hearings in order to present the department's position, provide information and clarification, and receive input from interested parties.

Develops procedures and ensures preparedness for emergency and disaster response and support services for homeless population; ensures staff are trained and prepared for disaster assignments.

Performs related duties as assigned.

KNOWLEDGE, SKILLS, AND ABILITIES:

Considerable knowledge of: the principles of public policy, planning, and homelessness and related services; federal, state, and local statutes, regulations, and legislative considerations governing non-profits, state, and/or federally-assisted housing and homelessness services programs and funding sources; the general principles of land use planning and zoning related to housing assistance; social, economic, and health-related community issues that contribute to homelessness; the principles and practices of providing community services; policy and procedural development and the analysis and evaluation of programs; grant administration, housing finance, and budgeting; fluency in racial justice and social equity concepts; effective supervision and management, including work planning and organization, and the selection and performance management of employees.

Ability to: effectively supervise and direct the work of professional, technical, and operations support staff; develop and maintain effective working relationships; successfully manage complex assignments; manage, plan, and organize various aspects of work relating to administration, budget, grant management, and general management matters; understand and interpret policies, data, and technical and legal documents; communicate effectively orally and in writing; develop and support strategic objectives; provide effective leadership, motivate

SUMMARY

In the August 24th CoC board meeting, staff was directed to explore and report back on several funding sources as possible avenues for resolving the gap in supportive services for current or future voucher holders. Staff was asked to follow up on:

- Cal-AIM (California Advancing and Innovating Medi-Cal)
- Future CoC funding
- Cities' funding
- Measure O
- Catholic Charities funding for families

Staff was also asked to explore reducing barriers to supportive services. This included exploring increasing wages, extending duration of contracts with service providers, different regulations between Public Housing Authorities (PHAs) and CoC-funded permanent supportive housing (PSH).

Staff was also asked to request that the Sonoma County Department of Health Services (DHS) be contacted to explore the feasibility of re-allocating some of its highly-skilled Interdepartmental Multidisciplinary Team (IMDT) staff to supportive services for voucher holders or towards services in other permanent housing.

RECOMMENDED ACTION(S)

DISCUSSION

Part 1 - Funding sources

- **CalAIM:** Staff met with Partnership Health Plan (PHP) staff to learn more about the CalAIM program and its tenancy services. CalAIM can provide supportive services to PHP members who have recently been housed. PHP is working with local service providers to begin services. Currently there are approximately 6 providers who are contracted to provide Housing and Tenancy services. Staff is going to meet with these providers to see how many clients they can serve and to develop a referral pathway for referrals.
- **Future CoC funding:** Supportive service agencies can apply for new projects annually during the CoC competition. This year, a special CoC NOFO was released that provided a second opportunity. Agencies can apply for Supportive Services only project models to serve newly-housed individuals however, staff did not receive any applications for the special NOFO and only 1 new project proposal for the general NOFO. In the FY 2021 Competition for Funding, two organizations did apply to increase supportive services through this funding stream and were awarded additional supportive services only to enhance their programming (Social Advocates for Youth and Catholic Charities). The opportunity for applying for future CoC funds has closed for this year, however. The CoC should plan to apply for a new CoC PSH project in the future that is paired with a housing subsidy (voucher/RRH not funded via CoC/ESG) as this has been highlighted the last two years in the funding competition. CoCs that pair housing subsidies with new CoC units receive extra points in the overall competition, and the project is more likely to get funded via bonus funds as an outlined HUD priority. SCCDC staff provided information on this HUD priority the last two years during each Bidders conference and scored projects on this. However, no new project applications were received or discussed with this option with SCCDC staff. CoC Program funding is competitive but annually renewable if the project is performing well.
- **Cities' funding.** At a future date, and as the Continuum of Care works more collaboratively with cities, service providers, health care providers, and philanthropy, it's possible that non-traditional funding sources such as contributions from cities may be viable. Today, not all cities have any level of homeless programming. As of the date of this report, staff has been working with cities to better understand what cities are spending on homelessness and related services.
- **Measure O.** Per a discussion at the recent (September 14, 2022) Measure O Citizens Oversight Committee, staff from DHS reported that the County of Sonoma may issue a future Request for Proposals (RFP) for available 2022 Measure O funds that were above planned expenditures. At this time, some of these dollars might be available for supportive services.

- **Catholic Charities’ funding for families:** There is a pot of funds to support families with children who are experiencing homelessness however at this time, the program details have not been fleshed out. It is hoped that when this project is operational, it will be able to support some of the EHV families with children.

Part 2 – Reducing barriers to better supportive services

- **Increasing wages:** Budgets for projects are created by agencies that apply for funding. In developing their budgets, agencies should consider the cost of quality staff and develop their budgets with more funding in the staffing budget line item. In order to increase funding through the CoC program, agencies would have to apply to expand projects. This can be done without increasing the number of units, just supportive services. In addition, CoC Program projects can also directly request an amendment from the local HUD Field office to shift budget line items that are over 10%; for example, an agency could move funding in their leasing budget to increase supportive services if they have identified another source of funding to subsize the units. Additionally, HUD expects agencies to be able to support their programs with outside funding. They never intend to be the sole funder of a project. Agencies should use discretionary funds, when able, to increase staffing.
- **Extending the duration of contracts:** Unfortunately, contract duration is determined by State and Federal funders. Staff cannot extend these programs. CoC funds are renewable and are generally funded year over year so long as they perform well.
- **Different regulations between Housing Authorities and CoC:** Below is a table of the conflict between CoC and Housing Choice Vouchers (HCV)/Project Based Vouchers (PBV) regulations. More detail is contained below the table. Homekey projects plan on using PBVs. Generally, they require adherence to housing first regulations (as noted as a CA State requirement in [Senate Bill 1380](#)) which creates similar conflicts.

Regulation	CoC-PSH programs	HCV/PBV
Background check requirement	Prohibited	Required
Minimum Rent	Prohibited	Required and determined by PHA. PHA can grant hardship exemptions to waive min rent

Use of Coordinated Entry	Required	Required for EHV and some PBV units however denials for background would create conflict with local CE policies
Means testing	No income limits. (this information is contained in an AAQ)	Income must be at or below 50% Area Median Income (AMI)

There are 4 areas of conflict between CoC-PSH programs and HCV/PBV vouchers.

1. **Background Checks:** In CoC programs, participants cannot be denied for a history of criminal activity. PBV and HCV program are required to deny participants for several specific offenses and may deny applicants for some criminal background. The local housing authorities conduct background checks on every applicant. Applicants are given an opportunity to appeal a denial decision.
2. **Minimum Rent:** PHAs are required to set a minimum rent. For the Sonoma County Housing Authority, this is \$50. Clients can request a waiver of this charge, however.
3. **Use of Coordinated Entry (CE):** CE is required for referrals to CoC-PSH programs. The use of CE is required for EHV and for some PBV projects that serve individuals experiencing homelessness. The conflict arises around rejections. There are only 4 specific reasons a CE referral can be rejected and the failure to pass a background check is not one of them.
4. **Means Testing:** HCV and PBV programs have an income threshold. Applicants cannot be above 50% of the Area Median Income (AMI). CoC programs do not have any income limits.

Part 3 - Proposed Solutions

- **Background checks/Coordinated Entry/ Means testing.** When projects can employ vouchers to subsidize rent at homeless-dedicated housing, they can redirect funds to supportive services making the project more financially viable. The funding that would be spent on rental assistance is redirected to supportive services.

A study could be done to see what the denial rate, after appeals, is for PBV/HCV projects that serve homeless individuals. After determining the denial rate, the project can roughly determine how many individuals will not be able to access a voucher in a year. Knowing this, the project can build their program budget with these denials in mind. Instead of

redirecting all the rental assistance or leasing funds to supportive services, some can be maintained in the rental assistance budget line item. If/When someone is denied, the client could be placed in a non-vouchered unit at the project. The CoC program funds can then support this client's rent while still redirecting the majority of the rental assistance or leasing funds to supportive services.

Those who are over income for vouchers can also be placed into non-vouchered units and the CoC program can pay the required rent through rental assistance or leasing funds. The client would still be required to pay 30% of their income or 10% of their monthly-adjusted income for the rent. A client with higher income would not require as much rental assistance as other clients.

- **Feasibility of re-allocating highly skilled IMDT staff to supportive services for voucher holders.** The Sonoma County Interdepartmental Multidisciplinary Team (IMDT) has two key cohorts that work or will work to assist homeless individuals and families. The teams include:
 - **HEART Cohort.** HEART's (Homeless Encampment Access and Resource Team) role is to work within encampments to determine housing and supportive services needs by individual, and then to clear the encampment with the help of local law enforcement and service providers. HEART Team members include staff members with various levels of advanced training, and team members can reach out to others in IMDT for more specialized advice and assistance. HEART team members also provide assistance to clients in Los Guilicos Village. HEART today has unfilled staff positions.
 - **Homekey Cohort.** This not-yet-staffed IMDT cohort will focus on providing high-level assistance to entities like Rohnert Park, Santa Rosa, Healdsburg, Petaluma, and the County team itself (at George's Hideaway) as they serve clients in the region's six or more Project Homekey sites. Staff members in these cohorts include substance use disorder experts, behavioral health clinicians, housing navigators, and more.

Due to low staffing levels for HEART and the ramp-up for the Homekey Cohort (as well as other mandated responsibilities for the cohorts), DHS believes that it is not feasible to reassign or reallocate IMDT staff towards other efforts that need supportive services at this time.

- **Expanding the overall pool of service providers (and related staff) in Sonoma County.** In September, Lead Agency staff contacted HomeFirst to see to what extent they may be interested in expanding their service footprint to include Sonoma County. Initially, the response by HomeFirst was positive. We will follow up on this pathway in the days to come.

- **Getting everyone in the same room to talk about this.** On Thursday, September 22 (too late for posting with this packet), the Lead Agency staff convened a group of service providers to discuss current and new strategies to address staffing shortages. Staff will provide more details about this when we can.

SUMMARY

DISCUSSION

Jurisdictions across the US conduct Point in Time (PIT) Counts typically annually at the direction of the US Department of Housing and Urban Development (HUD). The PIT Count is an attempt to determine who is homeless and either sheltered or unsheltered in that certain jurisdiction at any one point in time, usually in the last week of January each year.

Due to the COVID-19 pandemic, Sonoma County did not conduct a PIT Count in 2021. In 2022, the Count was delayed from the last week in January 2022, with approval from HUD, to Friday, February 25, 2022, due to the surge in the Omicron variant of COVID-19. The Count was conducted differently than in years past to ensure that appropriate safety measures were in place for the over 150 community volunteers who are paired with paid guides (individuals experiencing homelessness to maximize knowledge of areas canvassed). This shift in safety methodology, with all training virtual and the deployment itself done virtually (i.e., there was not a specific check-in point) rather than more in-person logistics, likely had an effect on the

Count's accuracy in 2022, resulting in greater fluctuations in subpopulation and census tract data.

The count of unsheltered persons is conducted from 5 a.m. to 9 a.m. across all census tracts in the county. The count of sheltered persons consists of data pulled from shelters and transitional housing during that point in time. In 2022, 2,893 individuals were counted, an increase of 5% from 2,745 individuals in 2020. 32% of respondents indicated that their current homeless episode was their first. In 2020, 31% indicated to be experiencing their first episode.

The 5% increase is in part due to the impacts of the COVID-19 pandemic, with housing more difficult to obtain and more individuals negatively impacted by financial impacts from COVID-19. Fortunately, survey information indicated that 57% of individuals had received their COVID vaccine, a testament to community outreach to individuals experiencing homelessness.


As Lead Agency to the Sonoma County Continuum of Care (CoC), the Sonoma County Community Development Commission (CDC) conducts the annual PIT Count to track progress towards ending homelessness in Sonoma County. US HUD requires a local PIT Count of any CoC to enable participating agencies to access HUD's CoC funding (in 2022, this is about \$4.1 million). Additionally, some State agencies use PIT Count data to formulate funding allocations. Further, when combined with the regularly inputted data from our Homeless Management Information System (HMIS), the Count informs the County's homeless housing needs.

The 2022 PIT Count of the number of homeless individuals identified in one night suggests that the total number of people experiencing homelessness in Sonoma County (unincorporated County and 9 cities) has increased slightly since the immediate aftermath of the COVID-19 pandemic by approximately 5% or 148 individuals to 2,893 individuals. The number of individuals in unsheltered circumstances grew from 1,702 in 2020 to 2,088 in 2022. Conversely, the number of individuals in sheltered circumstances dropped from 1,043 in 2020 to 805 in 2022. This reduction in sheltered individuals is likely caused by reduced sheltered capacities due to COVID-19 safety protocols, as well as concerns of living in congregate shelters during a pandemic.

There are numerous possible causes of the modest overall increase. Table 1 shows the trend over time for Sonoma County.

Point in Time Count of Homeless in Sonoma County since 2015



Service providers had reduced capacity due to the impacts of COVID-19, permanent housing was less available and more difficult to access, and the economic slowdown likely contributed to more individuals losing housing. 23% of individuals said that the loss of a job was the primary reason for becoming homeless (this was the top cause of homelessness in 2022). This compares similarly to data from the 2020 PIT Count (where 22% of respondents said job loss was their reason for homelessness).

Each year, following the PIT Count, surveys are conducted with individuals and families experiencing homelessness (both sheltered and unsheltered). This is done to gain insight on demographics and experience of single adults, families, and transition-age youth experiencing homelessness. These surveys, over 400 in total, are conducted in a peer-to-peer fashion in the two weeks after the PIT Count and include key information on homeless subpopulations, which HUD has identified as key to ending homelessness overall, as well as underlying causes of homelessness. Subpopulations of individuals experiencing homelessness include individuals experiencing chronic homelessness (defined generally as at least one year continuous of homelessness with a disability), Transition-Age Youth (TAY) between ages 18-24, homeless families with children, and Veterans. Within these subpopulations:

- 725 individuals experienced chronic homelessness, a 29% increase from 508 in 2020.

- 48 families (having at least one adult over 18 with one child under 18) totaling 155 individuals, were almost all found in sheltered circumstances. This is a decrease of 40% from 80 families in 2020 and a continued overall decrease in families from an all-time high of nearly 200 families in 2013.
- 23 unaccompanied children (persons under the age of 18 without parents) and 498 TAY ages 18

-24 were counted for a total of 521 youth, an increase of 67% from 304 in 2020.

- In 2022, 191 Veterans were counted, an increase of 37% from 139 in 2020.

By definition, the PIT Count only provides a snapshot of homelessness during a single point in time. It is a valuable tool but may not adequately reflect subpopulation data, due to methodology changes from impacts of COVID-19 (virtual trainings and less in-person guidance). However, these results indicate that the increase in our most vulnerable populations (chronic homelessness) as well as youth who have little credit history and a more difficult time on the rental market, are likely due to impacts on services and housing availability during the COVID-19 pandemic.

Additional key findings from the PIT Count and survey included:

- 68% of those experiencing homelessness became homeless while living in Sonoma County, an apparent decrease from any previous year. In years past, this percentage has been 80% or more. Staff believes that this may be attributed to a statistically errant over-sampling of individuals who did not become homeless in Sonoma County. We note that 50% of individuals indicated they had lived in Sonoma County 10 years or more.
- 23% of individuals cited job loss as the primary cause of their homelessness, and 63% of individuals cited unaffordable rent as an obstacle to securing permanent housing. Another 45% cited no job or not enough income as an obstacle.
- 89% of individuals who were unsheltered or staying in emergency shelter stated that they would move into permanent housing if it were available. 54% of individuals preferred housing without preconditions (“Housing First” settings).
- 25% of individuals identified as Latino/a/x, 8% identified as Black, and 9% identified as American Indian or Alaskan Native. Some of this data continues to reflect specific racial and ethnic disparities that exist in Sonoma County’s homeless population (i.e., where specific ethnicities are overrepresented in the homeless population when compared to the general population).
