POLICY STATEMENT

It is the policy of Sonoma County Juvenile Hall to place residents that pose an escape risk **and** are ineligible to be housed in maximum security Housing Unit 6, on Field Restriction for the safety and security of the facility.

PROCEDURES

1. GENERAL INFORMATION

- A. When a resident is placed on Field Restriction (FR) they are not allowed to go outside to the track & field area.
- B. Residents who pose a potential escape risk and cannot be placed in maximum security Housing Unit 6 due to classification or gender issues will be placed on FR.
 - i. Housing Unit 6 houses male residents only. As such, units housing high-risk female offenders may house residents requiring FR.
 - ii. Housing Unit 6 does not go to the track & field area at any time; all residents housed in that unit are considered to be on FR by default.
 - a) When a resident is transferred off of Housing Unit 6, their FR status will be rescinded unless otherwise structured in writing.
- C. Examples of classification or gender issues that would result in a resident being placed on FR include, but are not limited to:
 - i. Identified escape risk, or other circumstance in which a resident has been identified as a risk
 - ii. Out-of-County residents
 - iii. All 707b offenses.
 - a) Once adjudicated, 707b offenders may be removed from FR on a case-by-case basis, if recommended by the Classification Supervisor and approved by a Division Director (DD).
 - iv. Administrative Program
 - v. Protective Custody.
 - a) Offenders may be removed from FR on a case-by-case basis, if recommended by the Classification Supervisor and approved by a DD.
 - vi. Medical Isolation
 - vii. DJJ commitment or parolee.

- A. Recreation for residents on FR will take place on the unit small recreation yards 1 through 7, or one of the large recreation yards A, B or C.

3. IDENTIFYING A RESIDENT ON FIELD RESTRICTION

- A. Housing unit staff is to update the touchscreen information to indicate that a resident is on FR
- B. The Classification Supervisor will track all residents on FR, and assure that the information posted on the S-Drive is current by updating that database as required.

4. REVIEW OF FIELD RESTRICTION STATUS

- A. The Classification Supervisor will conduct reviews of residents on FR on a periodic basis or when changes occur with the resident's situation, in order to determine if continued FR status is warranted.
