Financial Reports

In March 2011, the Abalone Fund received \$75.00 from Central Collections, with a fiscal year fund balance of \$273.05, and a total fund balance of \$453.39. The General Fund received \$4,267.04 from Superior Court and \$650.18, from Probation, with a fiscal year fund balance of \$36,562.84, and a total fund balance of \$160,134.87.

Old Business

Kellie Noe, Program Specialist/Youth Ecology Corps Coordinator – Sonoma County Water Agency (SCWA), is requesting a grant in the amount of \$7,320.00, for *Summer Youth Ecology Corps*, second reading

Andy states that Chairperson Crystal Norris supports this grant request and asks if there are any additional comments or questions.

Al Ferris makes a motion to approve the grant in the amount of \$7,320.00, with a second by Jim Lynch. Motion carried with seven 'Ayes', four 'Absent', and one 'Abstain' (Dave Cook), for grant #153.

Captain Steve Riske, DFG, is requesting a grant in the amount of \$4,397.46, for *Russian River Enforcement*, pending

Lieutenant Rob Roberts, DFG, reports on behalf of Captain Riske. He explains that due to the transition in the State Governor's Office, DFG is still not operating with a Director and a response is still pending from the Auto Inspector with their General Services Department in regard to obtaining the vessel.

The consensus by the commissioners is that they would like to move forward to approve the grant request and ask that it be resubmitted by the Sonoma County Sheriff's Office. The Sheriff's Marine Unit would take ownership of the kayak for shared use with DFG. Lt. Roberts will contact Ed Hoener with the Sheriff's Office regarding this.

New Business

2011 Scholarships

The qualifying 2011 scholarship submissions are voted on by the Commission. Each application is assigned an alphabetical letter and the names of the applicants are kept confidential to ensure non-biased voting.

Al Ferris asks each of the commissioners to pick their top three candidates and the results are tallied. The two applicants receiving the most votes are Stephanie Parreira (A) and Katherine Robbins (F).

Caroline Christian arrives at 7:19pm, after the voting is complete; she mentioned at a previous meeting she would abstain from voting because some of the applicants from Sonoma State are in her classes.

She says Stephanie Parreira is one of her top students, holds a high GPA, works full time, and is very deserving of the scholarship. She feels the Commission made an excellent choice.
