Call to Order

b. Revenue/Budget Update

Report: CDFW is tracking case details from mid-February through early March, at which time the Commission will ask the District Attorney's office for assistance in reviewing misdemeanor cases for status and outcome. This is an ongoing process.

a. First reading of a Grant Request from The Laguna Foundation, for Nursery Shade House and Disease prevention material.

Report: Dr. Wendy Trowbridge and Brent Reed from the foundation presented their request and answered questions from the commissioners.

Action: There will be a second reading at the April meeting.

b. Commission phone extension at the Department of Agriculture/Weights & Measures.

Report: The commission has been presented with the request of discontinuing the existing phone line at the Department of Agriculture/Weights & Measures due to cost and infrequency of use.

Action: The Commissioners agreed that it would be cost effective to disconnect the phone line and refer the public to the main phone line at the Department Of Agriculture/Weights & Measures.

Passed with: 7 ayes, 0 nays, 3 absent.
